EVENTS UPDATES, REPORTS AND SCHEDULING

a. Ranch Hand Rodeo

Kim reports that the invitations have been sent to rodeo teams, vendors, dog trial participants, auction participants, and our food vendor. He notes that we have received positive feedback from participants regarding the event rescheduled to May 5-9, 2021.

Kent asked what the deadline is for rodeo team applications.

Kim replied that the deadline is March 1, so we should have a good idea of how many teams to expect at the next meeting.

Fergus asked about new incentives offered to prospective participants.

Kim replied that WCVA has authorized some added money for rodeo prizes and we have offered each team member one free stall.

Fergus commented that he had heard positive feedback about the added rodeo participant perks.

Tom reported that he has secured a stock contractor for the event.

Kim comments that Michelle is also working with Tommy Lee for added stock if needed.

2020 - 2021 BUDGET REVIEW - MODIFICATION

Kim presented the current budget report including revenue and expense transaction cleared as of February 4, 2021.

At approximately 60% of elapsed time, Tax revenue is at 61.39%. Fairgrounds revenue is at 139.33%, expenses are at 33.71%. Event Center revenue is at 86.21% with expenses at 42.06%.

Kim notes that Ag District #3 temporary labor expenses are over budget. He notes that we have \$30,000 temporary labor expenses that have not been spent in the Indoor Event Center account. He also notes that we have about \$52,000 unspent funds in the Honor Camp account.

No action was taken.

VOUCHERS – EXPENDITURES APPROVAL

Dale moved to approve the outstanding vouchers consisting of: \$3,951.14 for the Indoor Event Center through February 1, 2021 \$8,864.93 for Ag District #3 through February 1, 2021

The motion passed unanimously with Kent abstaining on items from Communication Creations because his spouse owns and operates the business.

Kim reports that the commissioners have approved adding a corrugated roof to Barn #9 and purchasing one additional Black Widow groomer.
