CALL TO ORDER

Kent called the meeting to order at 5:35 pm.

PUBLIC COMMENT

No public comment was presented at the meeting.

CORRRESPONDENCE REVIEW

No correspondence was presented.

EVENTS UPDATES, REPORTS AND SCHEDULING

a. SSIR

Dale is still working on safety policies for the next SSIR event. He comments that the board is considering all options including reducing the amount of golf carts available for rent.

No action was taken.

b. Jess Jones - NYE Bull Bash event

Kim reports that WCVA has not received the outstanding payment required of Mr. Jones before booking the facility in the future.

Kim asked about booking the facility with Souza's Bucking Bulls during the New Year holiday.

Kent comments that the date is open as far as the board is concerned.

No action was taken.

WINNEMUCCA EVENTS COMPLEX (WEC)

a. Request to add a full time employee

Kim reports that the County Commissioners have approved the addition of two fairgrounds attendants. He notes that some Commissioners have asked that some of the new resources be directed to preparing arenas and facilities for local use.

The board notes that while we may be able to work arenas for public use, our main priority is to keep the facility ready for events which bring people to town.

Kim also notes that the addition of two employees will cost approximately \$136,000 per year, which will need to be found within the current budget. He notes that the \$240,000 restroom project may be covered by Covid funds, so we may be able to cover the employee additions.

We will post the available positions internally within Humboldt County for the required amount of time before recruiting externally.

No action was taken.

2021 - 2020 BUDGET REVIEW - MODIFICATION

Kim presented the 2021 – 2022 budget including transactions posted through September 7, 2021. At 16% of elapsed time, Tax revenues are at 28.63%. Ag District #3 revenues are at 92.86%. Wage expenses are at 13.50% and Services and Supplies are at 20.77%. Event Center revenue is at 26.58%. Wage expenses are at 38.40%, and Service and Supply expenses are at 13.16%.

No action was taken.

Dale reports that he pulled 2 ripper teeth in the pavilion at the last event.

Kim comments that he constantly buys parts for the groomer equipment.
